

RESTRICTIVENESS OF LIVING ENVIRONMENT

Definitions – Anything below #13 is considered a step down from the IAFT pilot

Residential Level II should be coded as a 12 on the roles score****

23	Jail	A facility for individuals either detained prior to trial or convicted of a misdemeanor or felony
22	State Mental Hospital	A facility funded and operated by the state and typically removed from the community for the segregation of treatment of severely emotionally ill people. (Regional Hospital)
21	County Detention Center	A secure facility where youth are detained prior to adjudication .
20	Youth Correctional Center	A facility where previously detained youth,once adjudicated,are sent to serve out their commitment . (YDC/Boot Camp)
19	Intensive Treatment Unit	A hospital based or locked/staff secure treatment unit for acute psychiatric or drug/alcohol problems. (Private Psychiatric Hospital)
18	Drug Alcohol Rehabilitation	A secure, hospital based treatment environment center (Inpatient) for drug and alcohol services
17	Medical Hospital (Inpatient)	Treatment delivered within a medical hospital.
16	Wilderness Camp	An outward bound type program in which the (24 hour, year round) primary treatment is through a group process, primarily outdoors and isolated from the participant's social environment . (OTP)
15	Residential Treatment Center	A locked or unlocked residential care facility .(Intensive Program, Intermediate Program, Community Residential Substance Abuse, Therapeutic Group Home)
14	Group Emergency Shelter	Temporary congregate lodging program and services for individuals in acute crisis
13	Residential Job Corps Center	A federally sponsored program to increase employability with a residential component
12	Group Home	A residential facility providing lodging typically for four to eight individuals .
11	Foster Family Based Treatment Home	A home based treatment environment in which the foster family is trained and supported to plan and deliver care and services to a seriously disabled client . (TFC)
10	Individual Home Emergency Shelter	Temporary home based lodging and services for individuals in acute crisis
9	Supervised Independent Living	An individual lives independently with occasional, as needed support from professionals
8	Regular Foster Care	A family which provides parental care and nurturance (substitute family care) to a child not related through legal or blood ties
7	Home of Family Friend	Living in the home of a person who is known to the natural family but not related through legal or blood ties
6	Adoptive Home	A non biological family assumes permanent guardianship for a child who becomes a family member
5	School Dormitory	A facility providing lodging for a number of individuals attending a specific school
4	Home of Natural Parents for a Child	Living with one's biological parents as a child
3	Home of Natural Parents for an 18 year old	Living with one's biological parents after the age of emancipation
2	Independent Living with a Friend	Living without parental, legal or professional oversight, with a friend
1	Independent Living by self	Living by one's self without parental, legal or professional oversight or support
